

Structure of the Centres

An essential feature of a Centre is represented by the interdisciplinary network consisting of many health care partners of different specializations.

In all certified Centres, the structure of this network has some similarities. The identical network structures are very rarely encountered. This is consciously wished, because the purpose of the Centres is not the standardization of the structures, but the improvement of the patients' care.

Terms of appointment and registration of the cooperation partners

The official structure of a Centre, according to the specialty requirements, will be recorded by OnkoZert based on the data given in the offer request (offer request form) in a so called master data sheet.

Of course, patients can be treated by health care partners that do not have the status of a cooperation partner. It is also possible that a cooperation partner is active for several Centres. When appointing cooperative partners, one will take into consideration the fact that a recognition is possible only under the following conditions.

The cooperation partner actively participates in the continuous development of the Centre and respectively takes part in the Centre's actions (for example specializations, patients' information).
The relevant requirements in the Catalogue of Requirements are fulfilled.
The fulfillment of requirements is described for each cooperation partner in the Catalogue of Requirements.
There is a written convention between the Centre and the cooperation partner. The content of the convention is provided in the Catalogue of Requirements.
To the extent that for a specialty a mandatory participation is provided, according to the Catalogue of Requirements for the tumour board (e.g. radiologist, pathologist, radiotherapist), each appointed cooperation partner has to prove the participation in the weekly tumour board at least once a month. This is necessary even if the specialty is already represented by another cooperative partner on a continuous basis in the tumour board (monthly attendance is required at least quarterly).

Please check, based on this criteria, whether we are really talking about a cooperative partner or a healt care partner, with whom a common patient care is taken.

With this criteria it is possible to check, wheather it is a cooperative partner or a healt partner.

The circle of cooperation partners can be changed respectively extended during the annual audit (written communication to OnkoZert with at least 2 months before audit).

Defining the cooperation and health care partners

Interior circle	Leading/ management unit	 -leadership, management and coordination of the Centre -taking over multidisciplinary tasks, as for example: oncological documentation, professional development organization and public relations activities
Circle 2	Main cooperation partners	 -taking over important parts of health care -participation mainly periodically in tumour boards -involvement and collaboration within the Centre is settled in writing -check/inspection during certification regarding fulfillment of certification requirements
Circle 3	Cooperation partners	 -involvement and collaboration within the Centre is settled in writing -check/inspection during certification regarding fulfillment of certification requirements
Circle 4	Referrer	-certification requirements for referrers are not provided -a written convention will be established with the referrers, in which the collaboration is generally regulated (in particular, the participation to the Centre's events and collaboration regarding surveillance data)
Exterior circle	Health care partner	 no involvement in the network collaboration only regarding patients care which will be analyzed during the audit no special obligations within the Centre

Choosing the cooperation partners – recommendations

When forming the structure of a Centre, the certification system provides multiple possibilities and liberties. However, besides the skills of the cooperation partners, the following principles must be taken into consideration:

The geographical distance between the cooperation partners' premises and the main location (max. distance 45 km) Objective: small distances	The ideal situation is often considered that one where the cooperation partners are situated directly in the main location. Because this cannot be 100% insured, there is the possibility to have external cooperation partners (for example for genetic advice, radiology,)
Number of cooperation partners Objective: controllable number of cooperation partners	Each network needs management. The management expenses and the complexity of the network increases together with the number of cooperation partners.



More cooperation partners of a speciality	In many cases it is favorable to have one
Objective: as far as possible only 1 cooperation	cooperation partner per speciality. He has to
