A number of primary cases smaller than the imposed target value is a critical situation regarding the admission of initial certification, the maintenance of the certificate and the extension of the certificate. This directive contains the evaluation bases applicable for the specialized experts and the Certificate Awarding Committee and for (critical) situations of primary cases on different organs.

Initial certification

The conditions for audit admission and release of certificate:

Fulfillment of primary cases from the last calendar year and last 12 months.

Surveillance audit

In case of a positive audit result (=the auditor recommends maintaining the certificate, or as the case may be, solving the deviations) the maintenance of the certificate is possible even if the number of primary cases is not accomplished (a declaration regarding the situation of primary cases is required).

Addition (27.08.2012)

At the Ginaecology Cancer Centres the decrease in the number of cases from the imposed limit is limited to max. 10%.

Recertification audit

Condition for the legal certificate extension:

In the average of the last 3 calendar years, the target value of oncological cases must be reached (see the chart on next page). Thus, the proof of accomplishing the number of cases in "the last calendar year and last 12 months" is not enough.

The limited extension of the certificate (12 months) when:

- Accomplishing the number of cases in the last calendar year, but not the average of the last 3
 years.
- The number of cases is reached in the average of the last 3 calender years. However, in the last calendar year calendaristic the decrease from the imposed limit of the cases is greater than 20%.

For another extension of the certificate's validity, the number of cases must be accomplished for the last calendar year at the next audit.

When decreasing below the target value:

Suspension of the certificate for min. 12 months, starting from the "Expiry date of the certificate's validity".

The condition for reactivating the certificate is the achievement of a new audit, as well as a positive evaluation given by the Certificate Awarding Committee.

Primary evaluation of colorectal cancers (result of the Visceral Certification Committee of 17.03.2016)

For Colorectal Cancer Centres in case of recertification audits the following special regulation is available:

In the case of primary cases of 18-19 rectal cancer surgeries and/or 27-29 colon cancer surgeries, and if the result of the audit is normal, the certificate may be extended.

Cancer Centre

- The valid certificates of Organ Centres and Modules will be recognized in the analysis of the Cancer Centres.
- If the extension of a certificate is not possible in an Organ Centre, respectively a Module, the existing certificate for the Cancer Centre can be still be kept, even if some structural requirements for the Cancer Centre are not met temporarily (for example the number of the Organ Cancer Centre/ Module, validity domain quota, ...). The extension of the certificate for the Cancer Centre would not, however, be possible.
- The suspension of the certificate for the Cancer Cetre must be on minimum 12 months, starting from the "Expiry date of the certificate's validity".
